The decision was tabled until their next meeting on August 21, 2023.

# **DEPARTMENT HEAD REPORTS**

# AMBULANCE – Garth Kagels

Garth has an appointment with Horton Ambulance on August 15. He believes the chassis for the new ambulances will be delivered in September. There is still no word on the Chevy chassis for the remount. The concert at the Badlands went well. There were approximately 5,000 in attendance. He has an employee out due to back surgery. That will have an effect on the budget. Garth also reported that the lights have been installed and the driveway sealed.

# E -911 – Dana Stonebraker

She is paying out a lot of overtime. She has lost 2 operators. Dana is working on a communications grant for the CAD. She also has been communicating with Barry Ritter.

# EMA – Tina Holmes

She is working on the BRIC grant. It will pay 75% of the new CAD system, if we are awarded the grant.

A motion was made by Tim Shumaker and seconded by Brenda Hardy to appoint Tina Holmes as the EMA Director effective July 28, 2023.

# SHERIFF – Terry Holt

They are currently housing 12 inmates from Sullivan County, 3 parole, and 7 DOC inmates. There are 33 inmates from Fountain County. He reported that it is taking some time to get the glass for the cracked windows. It is about a 6 month wait. The plumbing problem has been fixed. He is ready to start the process for the new deputy spot. The design is completed for the lift station at the jail and is ready for bids. The Commissioners approved the advertisement for the bids.

# **HIGHWAY-** Jason Lewis

Jason reported that they have finished the chip and seal. They were able to do close to 40 miles. Greg Campbell has demolished Bridge #54 and has

got the beams on the bridge. They will be installing a new pipe on Powell's corner this week. They have the contract from Bridge #66. It has been sent to INDOT. USI will be at the next meeting. Milestone has not given a definite date when they will be starting the paving for the Community Crossing Grant.

### **HEALTH – Erich Haley**

Tim Shumaker requested status on a home in Stone Bluff. It is on the list that was recently sent to the County Attorney. The well and septic has been filled in. There was discussion on the unsafe building ordinance and the unsafe building fund.

### Hillsboro Sewer Project – ARPA funds

Roger Azar informed the Commissioners that Hillsboro received two bids for the project. One was for \$700,000 plus and the second one was for \$380,000 plus. The lower bid was under the amount originally planned for.

Roger also met with Genex Solar. They had questions on the legal drains. No permit application has been submitted.

#### IMPA – Purchase of Real Estate

The closing will be this Friday. The agreement has been signed with IMPA some time ago. A motion was made by Tim Shumaker and seconded by Brenda Hardy to grant permission to give the President of the Board or their designee the authorization to sign all documents at the closing. Vote: 2-0

#### **Courthouse Annex**

Alan Strawser has agreed to put a new roof on the Maple Corner Annex, take out the sky lights and all cooking vents. He will patch it with plywood and cover. The County will be receiving a little over \$36,000 from the insurance.
