**DEPARTMENT HEAD REPORTS**

**AMBULANCE - Garth Kagels**

Garth met with Horton Ambulance last week. We should have delivery of the chassis for the new ambulances in September or October. It will take approximately 70 to 90 days for completion. Also, Steve Donnelly received word that the new chassis for the remount should be delivered in September. It will take approximately 90 days also for completion. Garth would like to contract with a consultant to prepare the Medicare cost report. It has become very tedious and lengthy. He feels the county will get more dollars back if a consultant does the work.



EMA – Tina Holmes

Tina reported that the governor declared the June 29, 2023 storm -tornados a disaster. She is in the process of completing the paperwork.

SHERIFF – Terry Holt

Sheriff Holt reported that he had 76 inmates incarcerated. There are 2 parole holds; 8 DOC; and 13 from Sullivan County.

HIGHWAY – Jason Lewis

Jason is working with the county attorney to change some stop signs in the Bonebrake road area around Veedersburg. He also stated that they went to White County last week to tour their highway garage. It was completed in 2020. He will be meeting with RQAW soon. He has all of the brush equipment in the River Road area. He is preparing the roads for the new pavement that should be put down in September. He has not received the contract from INDOT on Bridge #66. It must be signed by September 1, 2023. The Commissioners will have to have a special meeting to accomplish this task.
