#### **DEPARTMENT HEAD REPORTS**

## Ambulance - Garth Kagels

Garth informed the Commissioners that the chassis for the new ambulances have been delivered. The 4<sup>th</sup> ambulance is up and running. He was able to hire some new employees to fill some of the vacant positions.

#### Custodian - Rick Beck

Rick updated the Commissioners on the E-911 bathroom. He stated that the bathroom toilet was replaced in the E-911 bathroom on the  $1^{\rm st}$  floor. Since that time, it has started to leak causing some damage. Slider came into look at it and remove some of the wall. However, they will need to check for asbestos and have it removed.

## **Sheriff - Terry Holt**

He currently has 70 inmates. There are 59 males and 11 females. Twelve are Department of Correction holds, 2 parole and 19 from Sullivan County.

## County Highway – Jason Lewis (via zoom)

Jason stated he has three positions open. He will be conducting interviews this week. He and Travis will be going to road school next week. He had planned to do approximately 60 miles of paving this year but will cut it down to 40 miles due to the lack of employees and the availability of aggregate.

## **ENVOY – Agreement for Professional Services**

The Commissioners have reviewed the agreement from Envoy. They have a few questions on the cost estimate for some of the proposed costs. The County has already had some of the work completed.
