**PUBLIC COMMENT**

**Alan McDonald**

He was requesting an update on the Hillsboro Sewer Project. They need an additional \$170,000 - \$180,000 to finish the project due to the increase in pipe. Alan McDonald will be putting in the line from the road to his property at his expense. It was suggested by Brenda Hardy to have an ARPA committee meeting. Tim Shumaker said a decision needs to be made.

Andrew Hall made a motion to allow \$170,000 for the Hillsboro Sewer Project upon the contingency that it is approved by the Council. Vote: 3-0

**DEPARTMENT HEAD REPORTS**

**SOIL & WATER – Lori Jordan**

Lori informed the Commissioners that there was a field fire at the County Farm on October 28, 2022. There was approximately 1/2 acre that was a total loss. The amount will be deducted from the year end billing.

**HIGHWAY – Jason Lewis & Travis Covault**

The capital asset plan (bridges) has been submitted to LTAP and approved. The plans for Bridge #66 have been turned in for review on the Federal Bridge project. The base of the road for CR 775 E has been installed. They will go back in a few weeks to cover with rock. Travis stated there were several signs blown down over the weekend due to the high winds.

**HEALTH – Jenny Eads**

She was inquiring about the County Health Ordinances. The name needs to be changed to Fountain County Health Department. The fees will not change. The County Attorney will amend them and have them for the next Commissioner meeting.

**CLERK – Paula Copenhaver**

As per statute, the Commissioners must appoint members to the vacant seats on Township Trustee Boards for each. This needs to be done by December 31, 2022. The Auditor will send notice to the paper. The Commissioners will appoint members at their next Commissioner meeting.

Paula's term ends December 31, 2022 she would like to buy her current computer that is over 5 years old. Paula offered to purchase it for \$50.

A motion was made by Tim Shumaker and seconded by Andrew Hall to declare the computer as surplus and dispose of it. Vote: 3-0
