Emergency Management- Tina Holmes

She had talked to the Commissioner president and offered to call Roger Azar. She will continue to do the floodplain at this time. Tim would like her to contact all Commissioners next time there is an issue. Also, she did not have her office tinted due to them watching weather. She had also talked to the president about that.

911 – Dana Stonebraker

Dana apologized for not being at the past few meetings, but she has been working night shifts to cover for employees who are taking time off. Her part

time dispatcher has finished up some training and is now ready to start answering some calls.

Landfill – Greg Robinson

Greg said he had talked with the Sheriff regarding some 4wheelers that have been on the property. He is going to also put signs up around the area. Greg and Tina did catch some of the trespassers and gave the names to the Sheriff.

Health Department – Jenny Eads

Jenny stated the new building has had an inspection and there is no mold. She has not seen the contract, but will get with Ethan. The current owner of the building stated he will not be able to get all the issues fixed by the time they want to move in and they may need to go through someone else.

Bill Brewer discussed the 60-day time line.


