





Discussion - BOT Contract for Highway Garage

Aaron asked the Council what they are thinking regarding money. He is thinking between \$4-\$6 million range. He would like to get started as soon as possible. Denise Crowder asked what all was included in that price. Aaron stated this would include the Salt Barn, Fuel Station and Main Building. Dudley said he would like to see designs. He would also like to see the County do this with no bonds. Denise would like to see it at the lower end.

Public Comment

Bill Brewer asked if it was possible to use Maple Corner for the new health department and possibly 911. Kelly said they had talked about it but the renovations would be too expensive. They discussed if anyone was interested in purchasing Maple Corner. Ethan Myers said several people are interested. Bill also said the previous commissioners said the evening meetings are not needed. Aaron Fruits and KW Rice stated that they are necessary. KW wants to give the working public a chance to attend a meeting and be updated on the County.

Carol Owens asked about different locations for the Health Building. There were 2 other buildings available. The Donovan Building has been looked at and it would be over cost due to renovations needed. Kelly was thinking the other building was a square footage building.

Kim Kalweit stated it was a good thing not many people attending. This showed the Council and Commissioners are doing their jobs.
