DEPARTMENT HEAD REPORTS

Highway- Jason Lewis

Jason had their contract for Bridge 202 that he presented to be signed by the Commissioners. They opened the bids today for CC. They have an on-call agreement with USI. This is \$49,000. Jason has letters of interest for bridge inspections. He brought a folder for the Commissioners to look over. Bridge inspection information have increased about \$15,000, but this was already put in the budget. He has met with Samsara and passed out information on their company. They are a Fleet management service. The first year would be \$9,800 and the next 2 years would be \$9,400. This is a 3-year contract. The highway does have money in equipment in 1169. He passed out the information. The highway department has been doing some grading on the roads.

Sheriff – Terry Holt

Sheriff Holt stated that the construction is going on over at the jail.

Andrew Krout discussed the additional Holiday pay for the Sheriff, Jail, Ambulance and 911. He gave some figures regarding the Sheriff and Jail. 4 deputies at 6 extra days for Sheriff would be \$3,888. On the jail side it would be 9 officers and an increase of \$8,748.

Bids

CC Bids were received from Ruth Riley and Milestone. A motion was made by KW Rice and seconded by Aaron Fruits to accept the bids and forward to Jason Lewis.

Ruth Riley was \$1,937,073.75.

Milestone was 1,928,338.00

Commissioner's Room/Auditor's Office

Tina Holmes would also like to have water at the EMA building. A bid has been submitted from Cheesman, Inc. for \$6,000.00. She does not have this in her budget.

Sue Anderson said that she has heard there are now 4 vacancies on the APC board. There is one position that has to be filled by the Purdue Extension office, 2 are democratic seats, and 1 is a republican seat. The Commissioners and Council have been discussing and are looking into the best way to get these positions filled. She asked if this would be on the website. She would also like to have the Public Hearings advertised on the website. This meeting was advertised in the Fountain County Neighbor. The Commissioners will look into possibly getting an app for county information. The public can also sign up on Fountain County alerts through the EMA office.

Bill Brewer

Bill Brewer would like to see Sue Anderson put back on the APC Board. He believes we need people with experience.

Deidre Bentley

She asked how this would affect her client who is working on the rezoning. The Commissioners believe they will be able to have the seats filled very soon.

There was an issue with a subdivision in Veedersburg. The rezoning administrator is also working for the developer. Some of the public believe this is a conflict of interest. They would like to make the Commissioners aware of the situation.


