### **Contract for Michelle C. Harter**

Several members of the Council had questions. Jim McKee felt like there was not enough information on her background and qualifications. Also, she said she had no experience with zoning. Kelly Carlson had given Jon Schrock some names from local attorneys. Jon had talked to a few other attorneys, but no one showed interest. Michelle is from Greenwood so there would be quite a bit of travel time. Aaron Fruits said he had no concerns with her as the attorney.

### 911 Floater Position

Dana Stonebraker has been asking about a floater position for 911. She does have someone who would be able to start right away. This employee would not receive benefits or overtime.

### Floodplain Administrator

Roger Azar received an email stating Tina Holmes had contacted DNR stating she is no longer the floodplain administrator. Roger was unaware of the change, but willing to take this position. The Commissioners stated they would like to discuss with Tina. She will remain the floodplain administrator until further discussion.

# **Health Dept Building Agreement**

Ethan Myers stated he has negotiated the interest rate down to 8% with \$35,000 down. This includes ½ acre along with the building. Ethan said the seller would fix everything on the inspection before the county takes possession. Ethan would like a public hearing on June 2<sup>nd</sup> before signing the contract. Dudley Cruea stated he would like to hear the public's opinion on this purchase. The goal is to have the purchase done by July 1<sup>st</sup>.

### **PUBLIC COMMENT**

Bill Brewer discussed SB425. He also contacted the author to get clarification. He stated that local authority would not be able to extend the moratorium more than 1 year. Tim Shumaker stated they needed to contact an attorney to see if this was retroactive or would begin on July 1<sup>st</sup>. Dudley stated in the meeting some Council members attended, they were informed that the county would be grandfathered in.

Bill also stated that County does not care about land owners rights. He stated he has talked to Ranger power and was informed that the assessment has already went up.

Sue Anderson stated she is unable to find minutes or agendas on the website. She also wondered if a copy of the contract would be available on the website. Ethan Myers stated this would be available in his office.

Jason Semler is still working on getting copies of the bonds for the council to review.

Jeff Fishero said SB1 is going to be a radical change for property taxes and LIT. Tim said this would be a good reason to have the Solar Farm money.
