Health Dept – Jenny Eads

Jenny wanted some guidance on moving forward on their vehicles. Would the Council like to replace or repair the current vehicle? They would like to replace.

EMA- Tina Holmes

Tina stated that they have been filling the back of the command trailer.

Highway- Jason Lewis

Jason discussed Bridge 103 and 105 are up for design. Bridge 103 will be up for bid end of November and 105 in February of next year.

Ambulance – Garth Kagels

Garth sent an email to Aaron regarding vehicles. He had discussed a new ambulance with the Council in 2026. Sourcewell can help with the process. A representative will be here on 11/3/25 to discuss. Highway also uses Sourcewell. They are short on staffing for ambulances.

Kim Kalweit

She did get a subcommittee together for the WEGA building. This includes the contractor, grant administrator, the architect, and the treasurer. She is hoping this project moves along quickly.

PHI Discussion

PHI has responded to 33 calls as of October 18, 2025. Twelve they have not shown up for and seven because of weather. This is a free service through the County.

Tammy Hinote- Van Buren Township

Tammy discussed how the County has not finished with the Solar ordinance and now they are jumping to the Data Center. She explained how data centers use a lot of electricity and water. She said the consumers will pay for the increase in costs. She said property values will decrease on properties surrounding these centers also.

Jessica Anderson -

Jessica stated that she didn't see the moratorium in the paperwork. Jon Schrock explained where it was. Jessica said this was the first she had seen these and asked when they were made available for the public. Chris Brunner pulled them up on the website and said they were posted October 6, 2025. Jessica said her recommendation would be to give people more time and more education to look through the ordinance. She didn't understand the rush. She said she sees a few issues with the ordinance also. She said her first direct edit would be on Article 11. She said she would mirror the special exception approval requirement of the land ordinance. She asked that the County look closer at this. She also mentioned the 5280 feet nonparticipating property notice. She said this could be challenged in court.

Jessica Anderson

She stated anyone is able to reach out to her. She wished she would have known and someone would have reached out to her. She stated she said she is a registered independent, but she voted in the republican primary. Jessica explained why she wanted to change the document. She said she can see where people are coming from, but she still feels like she should talk about being removed and later having her resignation letter accepted. She also wants the language to be looked out and changed on the special hearing.

Dane Maltsberger

Dane would like everyone to look at the facts. He would like decisions made based only on facts. He would like the fighting to stop and focus on preserving the County for future generations.


