The Fountain County Commissioners met September 4, 2007 at 9:00 a.m. at the Courthouse with the following board members present: Lowell Osborn, Terry Ellingwood and Janet Shoaf.

The Minutes of the August 20, 2007 meeting were read and approved.

**LOIT TAX**

Terry Ellingwood made available to the public copies of information regarding the Local Option Income tax. The council must vote on this by December 1, 2007.

**PRESIDENT/COMMISSIONERS**

Lowell Osborn resigned his position as President of the Commissioners effective immediately. There was not appointment made at this time.

**CLAIMS**

**ASSESSOR/TRANSFER**

Janet Shoaf made a motion and was seconded by Terry Ellingwood to go to the council with a request to transfer \$1,000.00 from Trustee Per Diem (0105-0000-01-412.080) and \$1,000.00 from Extra Clerical (0105-0000-01-412.075) to Board of Appeals (0105-0000-03-412.075) and \$1,000.00 from (0105-0000-03-431.360) Service Contract to Board of Appeals (0105-0000-03-412.075). Sandra Whitaker stated that this was due to the number of appeals this year.

**COUNTY HIGHWAY**

Walt Wilson stated that the guard rail was up on the Happy Hollow Road. He also extended the guardrail along Bridge #251.
