## **COMMISSIONERS**

Walt Wilson made a motion to go the Council with the request of \$75,000.00 for out of county housing in the 2009 Commissioner's Budget. Terry Ellingwood seconded the motion. Vote: 3-0

# COUNTY HIGHWAY

Rusty Peevler reported that the hydraulic motor is in disrepair on the chip box. It will cost approximately \$8,000 to \$10,000 to repair. They have parked it until funds are available.

He also received an estimate for a new snow plow in the approximate amount of \$9,600 from Rahn Equipment.

Rusty reported that they received an estimate in the amount of \$74,500 from CLR to repair the bridge on Covered Bridge Road.

Rusty believes 300 N between Hwy 41 and Hwy 341 is beyond the capability for the Highway Department to repair. He has received an estimate in the amount of \$160,000. Walt asked if he could apply for a grant to cover the costs of this project.

He also reported that Zackmire Road and Foster Road are open.

## **EMERGENCY MANAGEMENT**

The decision to approve the additional request in the amount of \$2,737.20 for maintenance on the computer server was tabled until Walt Wilson can get back with Joe Whitaker to get the pricing for the Class "D" classification.

## **HEALTH DEPARTMENT**

The Health Department has and will be incurring expenses for the move to the new building. They would like to know where to pay these expenses from. Walt Wilson will talk with Dr. Sharma on the matter.

**NJK FARMS  
PROPOSED SETTLEMENT**

Walt Wilson made a motion to rescind the motion to approve the proposed settlement agreement with NJK Farms. Janet called for a second. Terry Ellingwood asked that we add to the motion and ask that we send it back to our attorneys and Judge Baker and tell him that we are not opposed to an agreement but were uncomfortable with some of the points in the agreement.

Walt then made a motion to rescind the motion to approve the proposed settlement agreement with NJK Farms and have our attorneys take the agreement back to Judge Baker informing him that we are not opposed to a settlement but are uncomfortable with some of the points in the document. Terry Ellingwood seconded the motion.

He stated that one of our Sheriff vehicles was seen at a yard sale in Boone County. The Commissioners will look further into this matter and confer with the County Attorney.
