**DEPARTMENT HEAD REPORTS**

**Ambulance- Garth Kagels**

He reported on the mileage of his vehicles:  
2015 Wheeled Coach 90,007 purchased June 2015  
2015 Chevy AEV 29,765 purchased May 2017  
2015 4X4 Lifeline 63,343 purchased April 2016  
2010 Horton Ambulance V10 Gas Engine 197,741 replaced in August 2016 with mileage 184,000  
2008 Ford Expedition 126,978 purchased January 2014 with mileage 63,172

He reported to the commissioners about money he has recouped from Medicare. The amounts have not been as much as they used to because not everyone is going with Medicare anymore. They are going with other managed insurances, such as HIP. Example: 2015 - \$13,292 vs 2016 - \$9,508

He also asked for permission to list misc. equipment that is not being used on EBAY to try and recoup some funds that way. The commissioners all agreed that the Department Head could sell the equipment according to Resolution 2013-8: A Resolution setting Forth the Disposition of County Property dated May 6, 2013.

**County Highway- Bud Peach**

He submitted a request for a new hire. Brian Davis has put in his 2 week notice with his last day being March 30th. They agreed to the new hire to replace this position.

He also discussed his plan for working on the bridges over the next few months. The bridges that he mentioned were the Trojan Complex Bridge #126, Box Culvert 650N, #14, #25, #30, #122 estimated cost of \$375,000 and Bridges #62, #5, #142, #9 estimated cost of \$333,300 and Bridge #143 Hushaw Dawson of an estimated cost of \$12,000. He is estimating around \$720,300 to do all of the bridges.

**Auditor- Brenda Hardy**

Spyglass has found that the county is paying \$150 a month to have 22-25 phone numbers listed in the phone book. Brenda made an executive decision to cut it down to 4 numbers: EMA, LEPC, Sheriff/Jail and a general number for the courthouse. We are charged \$6 a month for each number listed so this will lower the bill substantially.

**Landfill -Greg Robison**

The #2 well had to be retested. Signage is needed out by the landfill. People are continuously dropping things off that shouldn't be dropped off at Solid Waste. Currently, there is only 1 camera that faces US 41. More cameras may be needed. Backwoods Graphics will be contacted for signage.

**New Wave - Fiber Optic Quotes**

The Judge’s office needs a higher speed of internet to keep up with the software that they now have. The price for the higher speed is \$900/month for 100M DIA and 50M EPL with \$500 installation fee or \$1,400/month for 200M DIA and 100 M EPL with installation fee waived. This amount would include most of the courthouse Currently E-911, EMA/LEPC, and the Jail have separate internet accounts. It is also being looked into whether or not to switch the phones from AT&T to New Wave as well and bundle it all together to save more money.
