DEPARTMENT HEAD REPORTS

County Highway – Bud Peach

An employee gave his letter of resignation. He has accepted another job. They will be needing to hire a replacement in order to keep the same amount of workers on staff. Chip & seal is almost done and odd jobs are being done. Brush cutting has been put on hold.

Ambulance – Garth Kagels

IEC did not renew their contract with St Vincent, Williamsport. The current Medical Director is Dr. Michael Tricoci and he's within the IEC and is a resident of Fountain County. He would like to stay on as Medical Director. The pay for him is \$2,500 a year. Don Hesler is going to put in a call to Jane at St Vincent, to get more information.

APPLE FESTIVAL

The Apple Festival Committee requested use of the Courthouse for the Apple Festival for the Mural Tours 11-2.

Performance Mechanical, LLC

Keller PC – quote \$2,200

A quote of \$2,200 was given to move the modem/switches/Ethernet, internet network etc. to be moved to the upper floor in the old traffic courtroom.

Keller PC – quote \$1,300

A quote of \$1,300 was given to purchase a new computer for the Veteran Officer and to be paid out of CCD or County General Maintenance.

Courthouse - Humidity / Temperature readings

Nancy Wagner relayed to the Commissioners that the engineers would like to come in and do readings of the humidity and temperature on all 3 floors. The new unit seems to be working but, they would still like to see the difference it is making. Craig will make contact with them to reassure them that the new system is working.

Courthouse Concrete – front entrance sidewalk

The entrance side walk in front of the courthouse is in need of repair. To redo the entire sidewalk will be very costly. They plan to use a caulking filler to the cracks that will self-level only for the 1st section closest to the door.

Older Mobile Homes – Stone Bluff
