MINUTES FOUNTAIN COUNTY COMMISSIONERS SEPTEMBER 4, 2018 8:30 A.M.

The following Fountain County Commissioners were present at the meeting: Craig Stalter, Don Hesler and Tim Shumaker.

PUBLIC COMMENT - None

DRAINAGE BOARD – ELMER E COATS DRAIN – Reactivate 18pay19 Scott Hathaway2006 pay 2007 collected \$1.50 per acre

He proposed to the commissioners that the Elmer E Coats Drain be reactivated and that a fee be collected by all that use the drain. The drain has not been active since 2006 pay 2007 and at that time it was being assessed at \$1.50 per benefitted acres in the Elmer E Coats Drain. The Drainage Maintenance fund has \$8,697.75 and the Drainage Improvements Fund has \$11,400 in it and there is much work that needs to be done to the Elmer E Coats Drain. They understand that if they do any work to the drain that they will not necessarily be reimbursed. A hearing needs to be held to make any changes to the status of the Elmer E Coats Drain. It would then be decided to reassess the drain at a different amount to pay for the repairs being done.

Scott Hathaway has found that 3,100 feet of tile needs to be laid and fix the clay drain that keeps collapsing due to the heavy amount of water. They would like to replace and put in a 24" main. He estimates it will cost \$75,000-\$80,000.

A motion was made by Tim Shumaker and seconded by Don Hesler to start charging \$1.75 for the year 18pay19 to all parcels that use the drain. This money would be put into the Maintenance Fund for future maintenance to the drain.

Greg Robison – Landfill

Mr. Wolf from IDEM came out for another inspection on the landfill. He left a list of things that need to be done yet. He is pleased with the work that has been done so far, but there is a lot more to do.

A proposal for getting rid of the extra material (1/3 of the amount) by Bell's Excavating in the amount of \$9,000 has been proposed.

MINUTES SPECIAL DRAINAGE BOARD MEETING SEPTEMBER 7, 2018 AT 2:00 P.M.

The following Drainage Board Members were present at the meeting: Craig Stalter, Don Hesler and Tim Shumaker.

Terry Martin and Bonnie Nix were in attendance as well.

Kent Minnette and Daniel Taylor from Taylor, Chadd, Minnette, Schneider & Clutter, P.C. Attorneys at Law, Crawfordsville, IN appeared in person to meet with the board to answer any questions regarding County Drains.

They gave to each of the Commissioners the "Drainage Law Basics" handout which included: Indiana Drainage Law Overview; Organization of the Drainage Board; Action Items pertaining to Private or Mutual Drains to a Regulated Drain; Special Issues such as determining a benefit, assessments, ordering reconstruction or construction, bidding and financing construction and reconstruction.

They spoke in detail about what their office would do to assist the county with drain issues and maintenance. They would be at every meeting and prepare any notices that needed to be done. They train their clients, so as the relationship grows, they are needed less and less. An engagement letter will be given to the board and it will state all that is covered by them. There is not a contract, so the county can drop them at any time. The attorneys would take the place of a County Surveyor and work with the Engineer on any projects that need attention.

Another subject that was discussed was the reactivation of Coates Drain and the steps to take in order to get the process started. It was stated that if the land owners want to do the work regardless of the board's decision, the cost will be completely on them. The board will have to vacate the drain at least until that certain project is done. The board needs to weigh the cost and benefits of the project before making a decision. It is not based on a majority ruling of the property owners, it is solely a board's decision to vacate the drain or move on with the project.

If a project is going to be more than \$75,000 it has to be bid out. If it is less than, the county will have to send out for quotes. All they need is a phone call from the board stating that it was approved for them to start working with the County.
