### Bill Brewer & Don Martin - 300 S

Don asked if someone from the county could come out to assess the ditch on the north side of the road within the first ¼ mile of the road. There is flooding when it rains, the culverts need care, the road isn't wide enough. Bud will look at the culvert to see what kind of repairs are needed. Bill asked if maybe some more gravel could be put down as it is thin on the sides and maybe make an area at the end of the road bigger for semis to turn around. Don stated that the Maple tree is an issue and is in the way.

### **Vectren - Transport Program**

Jennifer Isbell-Scott, Industrial Sales Account Manager shared with the Commissioners that based upon the estimated annual usage of 42,780 dekatherms that was provided this account qualifies to participate in Vectren's Transportation Program for the new jail. A motion was made by Tim Shumaker and seconded by Don Hesler to approve Vectren the ability to speak to Constellation directly on behalf of Fountain County and instructed the Auditor to provide the necessary documents or information that is needed by Vectren.

### **DECLARE 4-H WEEK**

4-H is the youth development program of our nation's Cooperative Extension System. ### **Bud Peach - County Highway**

Bud gave an update on roads and any issues that they might be having. They dug out on a culvert on McKinney Road due to animals digging into the dirt around the culverts and the sand around it washing away from the rain.

In order to get the 80% reimbursement for Bridge Inspections, the LPA Invoice Voucher needed to be filled out. It was filled out in the past by Butler Fairman & Seyfert when the county was under contract with them for bridge Inspections. Currently the county is under contract with VS Engineering but, they don't offer the service of doing the paperwork for the County so the highway dept. is doing that now.

### **Ambulance- Garth Kagels**

Garth gave an update on the truck with the fuel leak. It was going to cost \$1,700 for a new tank. He was able to get fabrication work on it at 1/3 of the cost.

They are looking into accepting credit card payments at the ambulance service. The square has a fee of 2.75% but, it doesn't offer a printout report like other credit card vendors offer. They are receiving 8-10 calls a month asking if they accept credit card payments.

Jeffrey Cawood, National Membership Representative of PHI CARES/PHI Air Medical would like to provide a short presentation to the County regarding membership with St. Vincent StatFlight. The county has approx., 6,963 houses @\$5 each with a yearly agreement of \$34,815. Garth explained a little what this service offered since Warren County uses them but, they have a hospital in their county.

# A RESOLUTION ESTABLISHING THE INTENT TO CONDUCT A COMMISSIONERS' SALE TO SELL TAX SALE CERTIFICATES FOR PROPERTIES THAT ARE SEVERELY DELINQUENT IN PAYMENT OF PROPERTY TAXES.

WHEREAS, there are several properties in Fountain County that are severely delinquent in the payment of property taxes, having been offered for tax sales and which received no bids equal to or in excess of minimum sale price. The parcel numbers of those properties being attached to this resolution as "Exhibit A", and

WHEREAS, there is an assessed value associated with these properties for taxation purposes, but no taxes are being collected, therefore causing a lower than expected tax distribution to those taxing units and taxing districts within which the properties are located, and

WHEREAS, the Fountain County Commissioners desire to have these properties back on the tax rolls with taxes being collected, and

WHEREAS, IC 6-1.1-24-6, *et seq.* allows for the Fountain County Commissioners to acquire a lien on those delinquent properties and receive issuance of the tax sale certificates for those properties, without taking title to the properties, therefore limiting the liability and cost normally associated with taking title,

**NOW, THEREFORE, BE IT RESOLVED** by the Fountain County Board of Commissioners that the County Executive shall acquire liens and receive tax sale certificates of the properties listed on **Exhibit A** that are severely delinquent and sell said certificates at a properly advertised Commissioner Tax Certificate sale.
