#### **LANDFILL - North Cell**

Roger Azar, PE Deckard Engineering/Surveying, PC gave a presentation on what needs to be done to the North Cell before they start the process all over. The North Cell lies next to wetlands. A Wetlands Investigation and Delineation Study on the northern edge of the landfill needs to be done to determine where exactly the lines are for the wetlands. If the wetlands are destroyed, it is very expensive (\$8,000 an Acre). The study will cost \$7,000. This will allow him to create the plan to not disturb the wetlands or as little as possible.

A motion was made by Tim Shumaker and seconded by Don Hesler to approve the Delineation Study and for it not to exceed \$7,000. Vote: 3-0

There needs to be an assessment done to see how much it is going to cost to fix the problematic drains. Roger will need to take aerial photos, etc. to assess the situation.
