The following Fountain County Commissioners were present at the meeting: Craig Stalter, Don Hesler and Tim Shumaker.

PUBLIC COMMENT -

National Register Nomination of the Cade's Mill Covered Bridge.

Nancy Wagner spoke to the Commissioners about the Cade's Mill Covered Bridge which was built in 1854 and is the oldest covered bridge in Fountain County. The historical society is attempting to have the bridge put on the National Register which is just a listing of a property that is architecturally, historically significant—one of prestige. Bridges need to be at least 50 years old. She will also be writing a grant to help with the maintenance of this bridge and Wallace Covered Bridge.

Bob Nadolski - Paved Road

He presented the commissioners with a signed petition of all of his neighbors on Snoddy Mill Road to have their road paved. The commissioners explained that there is not enough money to pave all of the roads in the county and that many of the roads have never been paved, not just his. He was not pleased with the response he received from the commissioners, so he asked to be on the agenda for the next meeting.

The transmission went out on the 1996 John Deere Tractor. The quote to fix it is \$20,000. It has been decided that it would be better to look into getting a new one or newer used one.

There are 16 bridges that were approved for the frequency inspection. This means that they would be on a 12 month section routine instead of a 21 month inspection. It will save the county some money.
