# TMA -

LOW Tax System is charging 20% on Total AV instead of just the added assessment value. There was discussion on removing the \$25 fixed fee along with the 20% for first 2 years. 20% will only be added to pay year 2020 and only for the added assessment that was found by TMA. There will also be a \$25 per year late filing fee for the three years.

Paula has gotten a quote for a new website to be done. \$6,500 for the initial start-up and then \$2,500 every year after. Three people would have access.

Our website is also not ADA compliant.

Kelly from the Health Department suggested Webco out of Danville, IL. Its only \$708 a year. The Commissioners requested more quotes to review.
