PUBLIC HEARING – USDA Rural Development Grant for Two New Police Vehicle Purchases

He let the record show that the Fountain County Commissioners opened the hearing at 9:02 a.m. for anyone to voice their concern or objection to the County applying to the USDA for a grant to purchase two sheriff vehicles. SEALED BIDS – Fountain County 2020-2 CCMG Projects (CR 750 N from SR 55 to SR 341 and CR 300 N from SR 341 to County Line Road)

A motion was made by Andrew Hall and seconded by Brenda Hardy to table opening the bids until the March 1, 2021 meeting. Due to inclement weather and County Travel Restrictions, the public was unable to turn in their bids for the County to consider. Vote: 3-0

KELLER PC - Cybersecurity Response Plan and Acceptable Use Policy

KELLER PC – QUOTE FOR ROUTERS – Routers for Courthouse and Jail (protect VPN between Jail & Courthouse)

DEPARTMENT HEAD REPORTS

Ambulance – Garth Kagels

There were no calls through the night of the storm (February 15, 2021). The Commissioners were going to ask the Highway Superintendent to have someone on call to plow if the EMS needs to get to a location. They were able to get the Green Army ambulance out and ready if needed.

Coroner – Josh Whittington

He will be bringing a couple quotes to the next meeting for a new camera for Staff to use at scenes/calls. They also will be needing a refrigerator to store samples/blood and other evidence from scenes. The refrigerator will be needed to be stored in a secure place. He would prefer it to be in its own building under lock and key, but a place at the Med Shed would suffice for now.

House Bill 1381 – Resolution 2021-2

This bill would make it so the State would mandate what the Counties can and cannot do concerning Solar and Wind Power. Resolution 2021-2 is expressing support for Local control of land use decisions.

A motion was made by Brenda Hardy and seconded by Andrew Hall to sign Resolution 2021-2 to try and keep control of land use decisions within our County. Vote: 3-0
