The following Fountain County Commissioners were present at the meeting: Brenda Hardy, Tim Shumaker and Andrew Hall.

PUBLIC COMMENT - None

Robert Lawson – Tim Shumaker spoke on behalf of Robert Lawson stating that Lawson owns all the property around a parcel (23-11-06-300-164.000-018) in Veedersburg. He would like to acquire this parcel as well. The County Attorney stated that two appraisals would have to be obtained and that the property could not sell for less than the average of the two appraisals.

Brian Cohen- He lives on South Cates Road outside of Kingman. He is having a major problem with a neighbor that has a lot of animals and their waste is flowing into his private pond killing his fish. He claims that the neighbor is purposely trying to poison his pond. He has had to put 2 aerators in the pond to help keep the fish alive. The County does have a nuisance ordinance. The County attorney will look over the ordinance and see if there is any action that the County can take against the neighbor. There is also a drain that goes through his land. Roger Azar has confirmed that it is not a county drain. Roger and Kent both agree he needs to seek private counsel to help in this matter.

DEPARTMENT HEAD REPORTS

Highway – Rusty Peevler

He put in for a large additional. Included in that additional is a Pneumatic Tire Roller, Double Drain Roller with vibrator, Single Pad foot vibrator roller, (2) Hotboxes and a paver.

All of the current equipment is over 25 years old and not in good working condition.

There is still a sink hole on 1400N. It is getting bigger and needs to be fixed immediately. Rusty stated that this road is very busy as many vehicles travel it on a daily basis. Stull's quote came in at \$26,100 and Bell's Excavating is \$26,800.

A motion was made by Andrew Hall and seconded by Tim Shumaker to select Bell's excavating for the project even though it was a higher quote. The decision was based on past work with the County, experience and the on-time bid completion for the scope of work. Vote: 3-0

A quote was received from Randy Slider of Slider Roofing to repair the metal roof and damaged decking on the Cades Covered Bridge in the amount of \$9,600.

A motion was made by Tim Shumaker and seconded by Andrew Hall to approve the \$9,600 bid to fix the Cades Mill Covered Bridge. They would like to pay for it out of the Covered Bridge line item in Cum Bridge. Vote: 3-0

Health Dept. – Kelly Thornburg

Kelly stated that she will be sending the paperwork to the State to close the OCRA grant as they are de-obligating the grant. She also asked if they could move \$1,800 to Fund 9777 to cover some administration costs they have incurred.

She also stated that Fund 9777 (CARES ACT) is in the red. For several weeks, the State keeps telling her that they will be sending more money in two weeks and it still has not come through. She is working to get the fund back in the black. The overtime for the clinic will be easing up. The vaccination clinic will be closing on May 25th. She will have 2 hours overtime every Wednesday and at least two hours on Saturday for the ones administering the vaccine on these days during the extended hours at the Health Department.

They received an \$8,000 grant along with 400 doses of vaccine from Mederna to have extended hours using the Mederna vaccine.

Each County received \$33,000 from the State. Since Fountain and Warren Counties are combined for the Health Department, they will only receive \$33,000 just like all of the other counties. She feels that both Fountain and Warren should get \$33,000 each. It is an 18-month award and it has been submitted.

There is an immunization grant every year in the amount of \$19,000. This year it can be used for personnel for COVID and can be put towards the negative balance in 9777.

EMA- Joe Whitaker

There will be a table top exercise in June. Several Counties are included in this exercise and the EOC will be opened up.

CLERK – PAULA COPENHAVER

She is in the process of standardizing the names of the townships on the voter registration. She will be bringing an Order to the Commissioners on renaming and re-numbering the precincts.

The Clerk's office will be closed on June 17, 2021. They are going to Conference for training.

Paula will be teaching a Constitution Class in July. It is a 6-week course, 1 night a week, for about $1\frac{1}{2}$ hours.

She is also rearranging the office to make it more functionable. There are a couple outlets that aren't working and need to be updated.

Roger Azar – Drains

The field work is almost done on the drains. He asked if the farmers could be made aware that they are working on them and will do their best to stay off of the crops. Since a lot of the farmers have planted all of the way up to the roads and drains, even though they aren't supposed to, it makes it nearly impossible to stay off of the crops entirely.
